

## Privacy Policy for JargonQuest

JargonQuest ("we," "us," or "our") operates the website (link unavailable) (the "Site"), a promotional platform for our blockchain-based rewards system on the Binance Smart Chain (BSC). This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you visit the Site or interact with our services, including staking in tiered pools (Mini, Midi, Maxi), claiming BNB rewards, freezing assets to earn JQ tokens, and related features. We are committed to protecting your privacy and handling your personal data in compliance with applicable laws, including the General Data Protection Regulation (GDPR) for users in the European Economic Area (EEA) and other relevant data protection regulations. By using the Site, you consent to the practices described in this Privacy Policy. ### 1. Information We Collect

We collect minimal information to provide and improve our services. Currently, as the Site is in testing and not fully live, data collection is limited. In the future, as features expand, we may collect:

#### Personal Information

**Voluntary Information:** If you contact us via any future forms (e.g., support inquiries), we may collect your name, email address, and message details.

**Wallet Information:** When interacting with our smart contracts for staking, claiming rewards, or token activities (e.g., freezing assets for JQ tokens, swapping, or burning), we may access your public blockchain wallet address (e.g., BSC address). This is pseudonymous and does not directly identify you unless linked to personal data.

#### Non-Personal Information

**Usage Data:** Automatically collected data such as your IP address, browser type, device information, pages visited, time and date of access, and referral sources. This helps us understand Site usage and improve functionality.

**Blockchain Data:** Public transaction details from the BSC network, including staking amounts, reward claims, and token interactions, which are inherently transparent via blockchain explorers. We do not collect sensitive personal information (e.g., health data, financial account details beyond wallet addresses) unless explicitly provided by you.

### 2. How We Collect Information

**Automatically:** Through cookies, web beacons, and similar technologies (see Section 7 for details). Also via blockchain interactions when you connect a wallet.

**Directly from You:** Through any future contact forms or support submissions.

From Third Parties: Public blockchain data from BSC nodes or explorers for transparency in rewards and transactions.

### 3. How We Use Your Information

We use collected information to:

Facilitate Site features, such as displaying pool balances, enabling staking/unstaking, and processing reward claims via smart contracts.

Ensure transparency and automate payouts in our BNB Rewards Pool, tied to community growth.

Improve the Site, including developing upcoming features like the Leaderboard.

Respond to inquiries or support requests.

Analyze usage trends to enhance user experience and security.

Comply with legal obligations, prevent fraud, and enforce our terms. Blockchain transactions are processed automatically via smart contracts, ensuring zero-delay claims without manual intervention.

### 4. Sharing Your Information

We do not sell your personal information. We may share information in limited circumstances:

Service Providers: With trusted third-party vendors (e.g., blockchain node providers, analytics tools) who assist in operating the Site, bound by confidentiality agreements.

Legal Requirements: If required by law, regulation, or legal process (e.g., court order), or to protect our rights, safety, or property.

Business Transfers: In the event of a merger, acquisition, or sale of assets, your information may be transferred as part of the transaction.

Public Blockchain: Wallet addresses and transaction details are public on BSC and visible to anyone querying the blockchain. We do not share additional personal data on-chain. No data is shared with advertisers or for marketing purposes at this time.

### 5. Data Security

We implement reasonable administrative, technical, and physical safeguards to protect your information, including:

Encryption for data in transit (e.g., HTTPS for Site access).

Secure smart contracts audited for vulnerabilities.

Access controls for any stored data. However, no method of transmission over the internet or electronic storage is 100% secure. While we strive to protect your data, we cannot guarantee absolute security, especially for public blockchain data. You are responsible for securing your wallet and private keys.

### 6. Data Retention

Personal Information: Retained only as long as necessary for the purposes outlined (e.g., support tickets for up to 2 years) or as required by law.

Usage and Blockchain Data: Retained indefinitely for analytics and transparency, but anonymized where possible.

Deletion Requests: You may request deletion of your data (subject to legal retention requirements) via our contact email.

## 7. Cookies and Tracking Technologies

The Site may use cookies (small text files stored on your device) for essential functions like session management and analytics. We do not use third-party cookies for advertising.

Essential Cookies: Necessary for Site operation (e.g., remembering pool selections).

Analytics Cookies: To track anonymous usage (e.g., via Google Analytics if implemented). You can manage cookies via your browser settings. Disabling them may limit Site functionality. For EEA users, we obtain consent where required under GDPR.

## 8. Children's Privacy

The Site is not intended for children under 13 (or 16 in some jurisdictions). We do not knowingly collect data from children. If we learn we have, we will delete it promptly.

## 9. Your Rights and Choices

Depending on your location, you may have rights under data protection laws,

including:

Access: Request a copy of your personal data.

Correction: Update inaccurate information.

Deletion: Request removal (subject to exceptions).

Objection/Restriction: Object to or restrict processing.

Portability: Receive your data in a structured format.

Withdraw Consent: Where processing is consent-based. To exercise these rights, contact us at [insert contact email]. We respond within 30 days (or as required by law).
