Terms & Conditions

JargonQuest BNB Rewards Pool

Effective Date: August 13, 2025 Last Updated: August 12, 2025

Key Facts – Quick Overview (For Informational Purposes Only)

Launch Date: August 13, 2025 at 14:00 (UTC).

Objective: Stake JQ Tokens in the Pool to earn weekly BNB rewards.

Eligibility: Active JargonQuest Telegram Bot Game account, referral link, unique hash code, and sufficient Social Points.

Minimum Deposit: More than 5,000 JQ per transaction (per Social Points limit).

Fees:

- \$100 BNB participation fee per deposit
- \$2 BNB recurring fee every 28 days
- Claim fee deducted when withdrawing rewards

Reward Cycle: Fixed 7-day cycle starting from launch date, regardless of deposit date.

Wallet Requirements: BSC-compatible wallet (MetaMask, Trust Wallet).

Security: Rewards locked in audited smart contract; no team access.

Risk Notice: Cryptocurrency investments are inherently risky; participation may result in partial or total loss of funds.

1. Eligibility

- 1.1 Participation is open only to individuals with an active JargonQuest Telegram Bot Game account ("Active Status").
- 1.2 Participants must use their personal referral link and unique hash code to connect to the Pool.

- 1.3 Individuals without an Active Status Bot Game account are not eligible to participate.
- 1.4 Participants must comply with all applicable laws and regulations in their jurisdiction.

2. Assets and Participation

- 2.1 Social Points Earned for free via the JargonQuest Telegram Bot Game or purchased through the Social Points Shop in the JargonQuest Bot Game. Social Points determine your participation capacity (e.g., 5,000 Social Points allow a maximum holding of 5,000 JQ). An equivalent number of Social Points must be frozen in the Telegram bot during participation.
- 2.2 JQ Tokens Earned for free via the JargonQuest Telegram Bot Game or purchased on a decentralized exchange (DEX). JQ Tokens are not available for purchase through the Social Points Shop. They are the primary asset used for participation.
- 2.3 The minimum participation amount is more than 5,000 JQ per transaction, subject to Social Points limits. Multiple deposits are permitted if Social Points capacity allows.
- 2.4 The maximum participation limit per transaction begins at 5,000 JQ and is reduced by half each quarter (e.g., $5,000 \rightarrow 2,500 \rightarrow 1,250$ JQ), with an overall Pool cap of 1 billion JQ.
- 2.5 To participate, users must:
 - Connect a BSC-compatible wallet (e.g., MetaMask, Trust Wallet).
 - Link their Telegram Bot Game ID or access via JargonQuest.com.
 - Deposit within Social Points limits.
 - Pay a \$100 Smart Contract participation fee per transaction.
- 3. Fees
- 3.1 Smart Contract Participation Fee: \$100 in BNB per transaction.
- 3.2 28-Day Recurring Fee: \$2 in BNB, payable between days 21 and 28 of each 28-day cycle, starting from the Pool launch date (August 13, 2025, 14:00 UTC). Non-payment will result in deposit closure. Deadlines are displayed on the user dashboard.
- 3.3 Claiming Fee: A percentage fee deducted from rewards upon claiming.

3.4 Failure to pay the 28-day fee within the specified period will close the user's deposits. To resume participation, a new deposit will be required.

4. Rewards

- 4.1 Rewards are distributed weekly based on each participant's deposited JQ share relative to the total Pool deposits and available BNB.
- 4.2 The reward claim cycle is fixed at 7 days from the Pool launch date, regardless of an individual's deposit date. The first claim will be available 7 days after launch.
- 4.3 An adjustable percentage fee will be deducted from rewards at the time of claiming.
- 4.4 All rewards are secured within the smart contract. Neither JargonQuest nor its team can access or withdraw user rewards.
- 5. Pool Growth and Management
- 5.1 The Pool grows through:
 - \$100 Smart Contract Participation Fees
 - \$2 recurring 28-day fees
 - Claiming fees

Additional BNB injected by the JargonQuest team

- 5.2 Revenue from the upcoming leaderboard gaming platform and Social Points Shop will contribute to the Pool, increasing growth and potential rewards.
- 5.3 If the BNB balance in the Pool is depleted, reward distribution will pause until replenishment occurs through fees or team contributions.
- 6. Withdrawals
- 6.1 Participants may withdraw their deposits at any time, forfeiting any unclaimed rewards for the current cycle.
- 6.2 There is no mandatory minimum participation period; however, the 28-day fee must be paid to maintain active status in the Pool.

- 7. Launch and Access
- 7.1 The Pool launches on August 13, 2025, at 14:00 UTC and will be accessible via JargonQuest.com.
- 7.2 The Pool operates on the Binance Smart Chain (BSC) and is compatible with wallets such as MetaMask and Trust Wallet.
- 8. Participation Limits and Adjustments
- 8.1 The minimum per-transaction deposit is more than 5,000 JQ (subject to Social Points).
- 8.2 There is no fixed maximum beyond the quarterly cap, up to the total Pool limit of 1 billion JQ.
- 8.3 Participants may increase deposits at any time with a new transaction, provided they have sufficient Social Points and meet current limits.
- 9. Risks and Responsibilities
- 9.1 Participation in the Pool involves inherent risks, including but not limited to:
 - Cryptocurrency market volatility, which may cause significant fluctuations in the value of BNB, JQ Tokens, or Social Points.
 - Potential smart contract vulnerabilities, despite audits and security measures.
 - Temporary or permanent pauses in reward distribution if the Pool's BNB balance is depleted.
- 9.2 Important Disclaimer: Participation in the JargonQuest BNB Rewards Pool constitutes a speculative and high-risk investment. The value of digital assets can fluctuate dramatically, and there is a risk of partial or total loss of your deposited assets. - 9.3 Participants are solely responsible for:
 - Using a secure, non-custodial wallet.
 - Staying informed about Pool updates, deadlines, and changes to these Terms.

- Paying the recurring \$2 BNB fee to maintain active participation.
- 10. Tracking and Support
- 10.1 Participants can monitor deposits, frozen Social Points, and rewards via the JargonQuest dashboard or Telegram bot, with updates provided weekly.
- 10.2 New users may join by:
 - Earning or purchasing Social Points through the JargonQuest Telegram Bot Game or Social Points Shop
 - Earning or purchasing JQ Tokens via the Telegram Bot Game or a DEX
 - Connecting a BSC wallet, ensuring an active Bot Game account, referral link, and hash code
- 10.3 For assistance, contact support through JargonQuest.com or Telegram, providing your wallet address and issue details.
- 11. Modifications and Termination
- 11.1 JargonQuest reserves the right to modify these Terms or terminate the Pool. Significant changes will be communicated via JargonQuest.com.
- 11.2 Continued participation after changes indicates acceptance of the revised Terms.
- 12. Governing Law
- 12.1 These Terms are governed by and construed in accordance with the laws of the United Arab Emirates (UAE). Any disputes shall be resolved in the competent courts of the UAE.
